

## **H&W Farms Sweepstakes Terms and Conditions**

### **Eligibility to Enter:**

### **To Enter:**

Participants must submit the following information to H&W Farms LLC, via social media messenger or email:

- A photo containing the hunter and the harvested deer
- Proof of date and location harvested (completed tag)

Information may also be submitted by mail to H&W Farms, LLC. Mailed submissions must be received the day before the weekly drawing date.

### **Rules to Entry:**

- Deer provided must be harvested within the dates of drawing week to be considered for that week's drawing. (ex; A deer harvested within the 9/25 - 10/9 drawing period cannot be submitted or resubmitted for the 11/20 - 12/4 drawing period)

### **Multiple Entries:**

Participants may receive 3x entries if they include a bag of H&W Farms Premium Game Corn in the submitted photo of hunter and deer.
